## 1. Story

For the manufacturer of portable systems for medical and industrial technology, which has been based in Hünfeld since 1945, the factor time plays a decisive role: As development partner for customer-specific medical solutions and applications, the prompt and reliable implementation of projects is essential. Therefore, the secured access to the required file directories on the company's file servers, which are distributed around the world, is of great importance.

Although the **Ondal Medical Systems GmbH** had already been using a well thought-out and structured manual access concept based on the folder owner principle since 2007, they decided in 2016 to implement a solution for automated access management.

With the **BAYOOSOFT Access Manager**, a tool was found that not only ensured faster approval processes, but also the release of IT resources and thus exceeded all requirements.

*“education” of the users and admins to follow this path and to make sure nobody was allowed to get access permissions without the approval of the responsible data manager.»*



With the use of the Self Service Portal, this process has been automated since using the **Access Manager**. The responsible data managers are involved in the operative access authorization process automatically. They grant access permissions for the directories they are responsible by accepting or rejecting the requests – completely without the involvement of the IT and permanently traceable via audit-proofed documentation and easy understanding reports.

Through the active integration of the responsible data managers and without having a detour via the user help desk, the release processes of access permissions could be significantly accelerated in the whole company. The releasing IT resources could now be used to retrieve IT services, which has been outsourced due to a lack of time and thus achieve cost savings.
